## TERMS AND CONDITIONS

**Effective Date:** 12<sup>th</sup> of March, 2026

**Last Updated:** 12<sup>th</sup> of March, 2026

These Terms and Conditions (“Terms”) govern the access to and use of the SpottedMe website and services (the “Platform”).

The Platform is owned and operated by **SpottedMe** (“Company”, “we”, “our”, or “us”).

By accessing or using the Platform you agree to comply with and be legally bound by these Terms. If you do not agree to these Terms, you must not access or use the Platform.

These Terms apply to all users of the Platform, including visitors, registered users, and any individuals who submit content.

### 1. PLATFORM OPERATOR

The Platform is operated by:

These Terms constitute a legally binding agreement between the user and the Platform operator.

### 2. DEFINITIONS

For the purposes of these Terms:

**Platform**

The website SpottedMe and all related features and services.

**User**

Any person accessing the Platform.

**Registered User**

A user who has created an account.

**Content**

Any text, post, message, comment, image, or other material.

**User Content**

Content posted by users.

**Services**

All features and functionality made available through the Platform.

### 3. NATURE OF THE PLATFORM

SpottedMe provides a digital platform where users may:

- publish anonymous “missed moment” stories
- browse stories submitted by others
- respond to posts
- communicate with other users through internal messaging tools

SpottedMe acts solely as an **intermediary hosting platform for user-generated content**.

The Platform:

- does not verify the identity of users
- does not perform background checks
- does not guarantee the accuracy of content
- does not guarantee user intentions

SpottedMe is **not a dating service**, matchmaking service, or identity verification platform.

Users interact with each other **at their own discretion and risk**.

### 4. ELIGIBILITY

Use of the Platform is restricted to individuals who are **18 years of age or older**.

By using the Platform, you confirm that:

- you are at least 18 years old
- you have legal capacity to enter into agreements
- your use of the Platform complies with applicable laws

The Platform is not intended for minors.

SpottedMe reserves the right to suspend or terminate accounts that violate age requirements.

### 5. ACCOUNT REGISTRATION

Certain features require account creation.

Users may be required to provide:

- first name
- last name
- email address
- phone number for verification
- date of birth
- password

Users must provide **accurate and truthful information**.

Users are responsible for maintaining the confidentiality of their login credentials.

Users are responsible for all activities that occur under their account.

If you believe your account has been compromised, you must notify the Platform immediately.

SpottedMe may suspend or terminate accounts where:

- false information is provided
- accounts are used abusively
- Terms are violated

## **6. ACCOUNT SECURITY**

Users are responsible for safeguarding their account credentials.

Users must not:

- share passwords
- allow others to access their account
- transfer accounts to other individuals

SpottedMe is not responsible for unauthorized account access resulting from failure to secure credentials.

## **7. USER CONTENT**

Users may submit content including:

- posts
- comments
- replies
- messages

Users are solely responsible for their content.

Content must not:

- violate laws
- infringe intellectual property rights
- contain defamatory statements
- disclose private information about others
- include abusive or threatening language

Submission of content does not guarantee that such content will be published or remain visible on the Platform. SpottedMe may restrict, delay, or remove content at its discretion.

## **8. CONTENT LICENSE**

By submitting content, users grant SpottedMe a **non-exclusive, worldwide, royalty-free license** to:

- host
- store
- display
- reproduce
- distribute
- archive
- moderate
- edit where necessary

This license exists solely to operate, maintain, and improve the Platform.

The license may continue for the period reasonably necessary to:

- maintain platform integrity
- investigate complaints
- comply with legal obligations
- retain backup archives

## **9. ANONYMITY RULES**

The Platform is designed to preserve anonymity.

Users must not share or request personal contact information including:

- phone numbers
- email addresses
- social media accounts
- residential addresses
- workplace information

Attempts to circumvent anonymity protections may result in content removal or account suspension.

## **10. PROHIBITED CONTENT AND CONDUCT**

Users must not post or engage in activities that:

- harass or threaten others

## **11. ANTI-DOXXING POLICY**

Users are strictly prohibited from posting or sharing identifying information about another person without consent.

This includes:

- real names
- workplaces
- contact details
- locations
- identifiable descriptions

Violations may result in immediate account suspension or permanent ban.

## **12. CONTENT MODERATION**

SpottedMe maintains moderation systems to protect users and maintain safety.

Moderation methods may include:

- automated filters
- keyword detection
- AI moderation tools
- human moderator review

Content moderation may involve the following states:

- Pending Review
- Approved
- Flagged
- Blocked
- Rejected
- Archived

SpottedMe reserves the right to restrict visibility, refuse publication, remove content, suspend features, or terminate accounts where content violates these Terms or applicable laws.

Moderation decisions may be based on automated signals combined with human review.

### **13. REPORTING AND APPEALS**

Users may report content that violates the Platform rules.

Reports will be reviewed by moderators.

Actions may include:

- warnings
- content removal
- temporary suspension
- permanent account termination

Users who believe moderation decisions were made in error may contact SpottedMe via the contact email listed in these Terms. SpottedMe may review such requests but is not obligated to reverse moderation decisions.

SpottedMe reserves the final authority regarding moderation outcomes.

### **14. USER SAFETY DISCLAIMER**

SpottedMe does not verify user identities.

Users should exercise caution when interacting with others.

SpottedMe does not conduct background checks and does not guarantee the identity or intentions of users.

SpottedMe is not responsible for interactions or meetings that occur outside the Platform.

### **15. FUTURE PAID FEATURES**

Currently the Platform does not charge fees.

SpottedMe may introduce optional paid features including:

- promoted posts
- highlighted visibility
- priority listing

If introduced, all pricing, billing conditions, and eligibility requirements will be clearly disclosed before purchase.

Participation in paid services will always remain optional.

### **16. ACCOUNT TERMINATION, SUSPENSION AND DELETION**

#### **16.1 Account Deletion Requested by the User**

Users may request deletion of their account at any time by contacting SpottedMe via email at [info@spottedme.com](mailto:info@spottedme.com).

Upon receiving a valid deletion request:

- the user account will be deactivated
- access to the Platform will be revoked
- personal account data will be removed or anonymized where reasonably possible

SpottedMe may request verification of the user's identity before processing an account deletion request to ensure the request is legitimate.

### **16.2 Data Retention Following Account Deletion**

Following account deletion, certain information may be retained for limited periods where necessary to:

- comply with legal obligations
- investigate or resolve disputes
- enforce these Terms
- maintain platform safety and security
- prevent abuse or repeated violations
- retain records related to moderation actions or user reports

Where possible, retained information will be anonymized so that it no longer identifies a specific user.

### **16.3 Suspension or Termination by SpottedMe**

SpottedMe reserves the right to suspend, restrict, or permanently terminate user accounts at its sole discretion where it reasonably believes that a user has:

- violated these Terms
- engaged in abusive or harmful behavior
- attempted to bypass platform safeguards
- engaged in fraudulent or illegal activity
- attempted to manipulate or exploit platform systems
- repeatedly violated platform policies

Enforcement actions may include:

- temporary account suspension
- removal of specific content
- restriction of messaging capabilities
- permanent account termination

SpottedMe may take such actions without prior notice where necessary to protect users, maintain platform integrity, or comply with legal obligations.

## **16.4 Effects of Termination**

If an account is suspended or terminated:

- the user may lose access to their account and associated content
- access to the Platform may be restricted or blocked
- the user may be prevented from creating new accounts

SpottedMe may retain moderation records or logs associated with terminated accounts where necessary to maintain platform safety and prevent misuse.

These Terms are governed by the laws of the **Republic of Cyprus**.

Any disputes shall be subject to the jurisdiction of the courts of Cyprus.

#### **25. SEVERABILITY**

If any provision of these Terms is deemed invalid or unenforceable, the remaining provisions remain in effect.

#### **26. CHANGES TO THESE TERMS**

SpottedMe may update these Terms at any time.

Updated versions will be published on the Platform with a revised effective date.

Continued use of the Platform constitutes acceptance of the updated Terms.
